Initials can be confusing but it seems to be easier when the names are so long. HPPOA and NFNCC are completely different organizations but do share a common goal and occasionally work together. I like to think that the HPPOA builds and maintains a house while the NFNCC tries to make it

Harbor Point is a deeded community, which you should be aware of when you purchase property here. Those rules are enforced by the Harbor Point Property Owners Association (HPPOA). If you are a property owner, you are part of HPPOA. As a group we elect board members to run the HPPOA. As property owners we pay the association dues and they provide the needed services for the community. They see that the rules are followed and use our dues for our guards at the gate, the staff in the office, any needed extra security, general maintenance, mowing of common areas, road repairs, lights on the streets, electricity and water for the pool, marina and clubhouse, trash removal, all the things necessary for this to be a livable place.

The Neighbors for Neighbors Community Club (NFNCC) is a voluntary club. It is open to all residents and owners who want to make Harbor Point a nicer place to live. We aim to improve and beautify Harbor Point as well as provide help to our neighbors in time of need. We provide meals to families after the death of a loved one, welcome new residents moving into the neighborhood, remember residents who are ill, generally try to be a good neighbor. Our money comes from dues (\$10 per year) and fundraisers. We use our money for neighborhood projects. We have donated money to HPPOA for road repairs and to lawyers that help fight our outrageous water bills. We do the holiday decorations at the gate, this newsletter, hosted a first aid/CPR class, spruced up various areas in the neighborhood, built a pavilion by the marina for community use, lots and lots of things. In fact, elsewhere in this newsletter is an impressive list of things we accomplished in 2013.

The club's fiscal year is March 1 to the last day of February. If you would like to be a part of NFNCC, now is the perfect time to join. We meet the second Tuesday of the month (March 11) at 6pm in the clubhouse. The meetings are fun, round-table type discussions, usually lasting until around 7:30 and end with yummy treats. OUTDOOR REPORT

If you know or suspect a venomous water moccasin snake

SNAKES

— also known as the cottonmouth moccasin snake — has bitten someone, prompt treatment is imperative. Symptoms include pain, swelling and bleeding at the site of the wound, difficulty breathing, low blood pressure, nausea and vomiting, numbness and tingling, skin-color changes, thirst, tiredness, tissue damage and weakness. The most vital effort after a cottonmouth snake bite is that of surviving the bite. Just like any other snake bite, the bite from these guys can be lethal and because injection of venom is voluntary, venomous snakes may occasionally deliver a "dry" bite in which no venom is injected. This can occur when snakes produce a superficial bite or are panicked. About one in five bites to humans from venomous snakes are in this category. At other times only a specific amount of venom is injected. Due to the spongy nature of the glands it is nearly impossible for a snake to expel all of its venom. When most of the venom is expelled from the glands, between 15 and 20 days are required for the secretary tissue to refill the glands. However, secretion appears to be rapid during the first few days, so that venomous snakes may possess dangerous quantities of venom within a day or two of its expulsion. Cottonmouths are venomous semi-aquatic snakes often referred to as "water moccasins". Most certainly fatal if not treated in good time. However, rapid and proper response can contribute significantly to the survival of the victim. Truth be told there have only been a few cases of cottonmouth snake bites resulting in a death but extreme caution and due regard is a must.

The name "Cottonmouth" comes from the animal's defensive behavior that it displays when it feels threatened. It coils up in a circle and opens its mouth nice and wide displaying an impressive set of retractable fangs as well as the classic cotton white mouth. Also, being that their native range is primary in the southern cotton growing region of the United States so the name cottonmouth was more fitting. They're also referred to as water moccasins in some rural areas.



RECIPES



BANANA BREAD

1/3 cup vegetable oil

1 ½ cups mashed ripe bananas (about 3 large) ½ teaspoon vanilla

3 eggs

2 1/3 cups buttermilk baking mix (bisquick)

1 cup sugar

1/3 cup chopped nuts

Heat oven to 350 degrees.

Generously grease the bottom of a 9x5x3 inch loaf pan.

Stir together oil, bananas, vanilla, eggs, baking mix, sugar and nuts with a

fork until moistened; beat vigorously 1 minute.

Bake until a wooden pick

inserted in the center comes out clean, 55-65 minutes. Cool 5 minutes. Run a

knife or metal spatula around sides of loaf pan to loosen; remove from pan and let cool.

PERFECT CORNBREAD

1 cup sifted all-purpose flour 1/3 cup sugar 4 teaspoons baking powder 3/4 teaspoon salt 1 cup yellow cornmeal 2 eggs, beaten 1 cup milk 1/4 cup shortening

Sift flour with sugar, baking powder and salt. Stir in cornmeal. Add eggs, milk and shortening. Mix with a wire whisk or spoon until blended. Do not overbeat. Spoon into a greased cast iron skillet. Bake at 425 degrees for 20 minutes or until browned. Cornbread will not usually stick if you first grease the pan and heat until very hot, and then spoon in batter.

I just put the shortening in the skillet and when the skillet gets hot pour the

melted shortening into the mixture and then pour into the hot skillet.

Tip-Never wash a cast iron skillet with soap. You can wash out with cold water.

The skillet must stay seasoned with a greasy residue in order to keep the cornbread from sticking.

These are the projects you helped fund

We started by cleaning the park next to the club house, painted see saws, tilled the sandy area twice where the volley ball court is located, replaced volley ball net, purchased volley ball and had a trench dug to keep the sand from washing away on the volley ball court. Removed the dangerous platform that was falling apart going down to the water between the boat launch area and the fishing pier. Pressure washed the boat slip, which had spider webs hanging from the roof up to four feet long. Cleaned the park at the pool, cut down all Yaupons growing at the base of trees, trimmed branches up to 16 feet high.



Replaced and counter tops in both bathrooms at the pool, painted the bathrooms from top to bottom, put up a privacy curtain in front of showers, scrubbed the showers and replaced the lockers in the pool area.



Tore down and replaced the fence around the dumpsters on Harbor Point Drive.

Painted the wooden shed over the mail boxes and sweeping down spider webs about once a week. Painted the curbs at the front entrance a bright yellow, painted the flag poles and painted the fence and stair railings at the office. Painted the speed bumps throughout the subdivision.

Took down the basketball goal at the court next to the club house and turned it into a pavilion. A real nice neighbor Ron Hudman donated a BBQ pit for the pavilion. Poured cement slab for grill, set grill up and purchased the metal covering for the pavilion.



Drilled holes in the fence rail at the park next to the club house so flags can be displayed at several appropriate times during the year and installation of the PVC pipe at ground level every 5 foot at the entrance so flags can easily be displayed. Vic McGuiness donated a storage building, it was repaired & painted. The decorations are stored in it. We purchased 2 heaters, a small air conditioner for the club house and 2 solar motion sensor lights for the entrance to the club house.

Made 4 escape routes around the brush next to the lake at the club house so a controlled burn can be made. There is a hugh pile of dead trees and bushes on the cliff between the park and the water next to the club house.

We also prepared bereavement dinners for families as needed.

We took up donations for a neighbor who lost their mobile home to fire.

So as you can see we have done a lot with the money that we have raised.
